Registration-includes a NH t-shirt & a camp drawstring bag, (non-refundable registration fee) waived for full time NHCDS 2015-16 students who sign up for 6 weeks of summer camp. This registration fee will be charged for students who for whatever reason do not keep their agreement of 6 weeks.

TUITION - please check

- \$147.00 weekly for Tuition Express** families payable at the beginning of scheduled weeks, non-refundable and non-transferable.
- \$157.00 weekly for Non-Tuition Express** families at time of registration, non-refundable and non-transferable, 50% of each session must be paid by May 13, 2016.

Campers are required to be at camp by 9:00 AM to attend camp on each particular day. If a child will not be in attendance a phone call by 9:00 is requested so not to detain a field trip. Attendance is not mandatory but optional, however, tuition will not be adjusted due to non-attendance. Fees have been structured to include tuition, arts/crafts, daily snacks, supplies, non-charging field trips and special projects. A field trip fee will be assessed to defer costs only when necessary. New Horizons is committed to working with all types of students, however, we are unable to accommodate students who disrupt our program. If you are paying the Non-Tuition Express price the remainder of the tuition, covering chosen sessions, is due on the first day of each session. **A late fee of \$20.00 will be assessed to tuition paid after the agreed dates or the first day of each week in a chosen session.** A service charge of \$35.00 will be added to any account for which there is a returned check or insufficient funds. You will be financially responsible for sessions that you choose to cancel/drop out of after May 13, 2016.

I have read and understand my responsibilities to New Horizons Country Day School. By signing below I understand that I am responsible for the payment of services provided. If for any reason I am delinquent in my payment, I will be responsible for the cost of any collection and/or late fees. I understand that any cancellation or changes made after 5/13/2016 will result in my tuition fees to increase to the non-tuition express price and a 50% deposit will be due. I acknowledge that fees are non-refundable and non-negotiable. Tuition is due regardless of attendance and will be withdrawn via Tuition Express per tuition agreement.
